

The following report is provided as a requirement of the CARES Act to describe the use of funds distributed from the Higher Education Emergency Relief Fund (HEERF) as of December 31st, 2020.

On April 13, 2020, Mission College signed and returned to the Department of Education (ED) the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

The total amount of funds that the institution has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to students:

Mission College has received HEERF I for \$1,961,952.00 and HEERF II for \$4,110,909.00. No less than 50 percent of HEERF I (\$980,976.00) and \$1,000,000 of HEERF II, will be used to provide direct Emergency Financial Aid Grants to students.

The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of December 31st, 2020.

Mission College has distributed \$2,424,683.00 to students under Section 18004(a)(1) of the CARES Act as of the date of this report.

The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

The total estimated number of eligible students for Title IV is 12,352. Eligible students estimate is as follows: Fall 2020-7628 and Spring 21- 4624.

The total number of students who have received an Emergency Financial Aid Grant to students under Section 18004(a)(1) of the CARES Act.

9080 students have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act as of the date of this report. This number includes eligible students paid under the California Community Colleges [Legal Advisory 2020-07: Student Eligibility for CARES Act Emergency Aid](#).

The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act.

Eligible students met the following requirements:

- **Submitted a 2020-21 Free Application for Federal Student Aid (FAFSA) or a California Dream Act.**
- **Actively enrolled at Mission College for the Spring 2021.**

- **Full-time students (greater than 12 units) enrolled for the Spring 2021 semester are awarded \$650.**
- **Part-time students (less than 12 units) Enrolled for the Spring 2021 semester are awarded \$500.**
- **Students enrolled in at least 6 units for the Spring 21 semester are awarded \$250.**

Instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

On the Mission College [Resources for Students & Families](#) website an Emergency Financial Assistance resource page and intake form is available to inform and capture as many students as possible. All CARES Act grant recipients were sent an award notification email which explained what the grant may be used for, amount, date and method of the disbursement, contact information and additional student resources available on campus.
